#### What is eVISA?

eVISA is an online application platform that enable foreign nationals to apply for an electronic visa to enter Malaysia at the comfort of your convenience.

eVISA can be applied around the world EXCEPT Malaysia, Israel and North Korea. Effective from December 1, 2023, until **December 31, 2026**, nationals of the **People's Republic of China** and **India** are **EXEMPTED** from visa requirements for tourist purposes (Single Entry Visa) when traveling to Malaysia.

Afghanistan passport holders must obtain a VDR before applying for an eVISA, except for holders of Diplomatic and Official passports.

# Who is eligible for eVISA for the purpose of Study / Employment / Medical Treatment / Foreign Worker?

Foreign nationals who have received approval for their eVAL or VDR are eligible to apply for an eVISA.

### How long will my eVISA be valid for?

Single Entry Visa (SEV) obtained through the eVISA system allows for single journey to Malaysia within 6 months from the date of issuance. However, for foreign workers category, this visa is valid for 3 months from the date of issuance, with the condition that their passport remains valid.

Multiple Entry Visa (MEV) for an eVISA is only valid for multiple journeys to Malaysia within 6 months from the date of issuance, with 30 days stay allowed for each entry, provided that the applicant's passport remains valid.

#### How do I get started?

For a first time applicant, you are required to click on "I'm New" to start your application process. For existing applicants, you are required to click on "Returning User" to return to your account.

# What documents do I need to apply for eVISA?

Below are the documents that need to be scanned and uploaded with your application.

- Passport sized studio photo;
- 2) Passport biodata page with validity of at least more than 6 months from travel date;
- 3) Confirmed return ticket if applicable;
- 4) Birth certificate for minor applicants;
- 5) Proof of paid accommodation;
- 6) Other supporting documents such as bank statement, current residing country pass/visa, and long-term pass.

# What is the approval process for eVISA?

Your application is subject to approval by the Immigration Department of Malaysia or Malaysian High Commission / Embassy / Consulate. Kindly be informed that in the event of suspicion, applicants may be required to supply further documents or be called for physical interview or online video conference with Malaysian High Commission / Embassy / Consulate.

# Will I have to print out my eVISA?

Yes, you are required to either print out your eVISA in an A4 format or present the digital eVISA. Kindly be reminded that your eVISA, whether in printed or digital format, is crucial and must be presented upon your arrival at Malaysia entry checkpoints.

#### How will I be contacted for my eVISA application?

You are advised to be alert with any email notifications from us, as the means of communication will be through email.

# What are the documents needed upon arrival at Malaysia entry checkpoints?

The following documents are required to be presented upon arrival in Malaysia entry check-points:

- 1) Valid passport / travel document;
- 2) Valid eVISA printout or Digital eVISA (eVISA Note);
- 3) Boarding pass / ticket / arrival pass if applicable;
- 4) Confirmed return ticket if applicable;
- 5) Proof of paid accommodation;
- 6) Other supporting documents such as bank statement, current residing country pass / visa, and long-term pass.
